**A RESOLUTION APPOINTING ADDITIONAL MEMBERS TO
THE SPI-9 BUCKHEAD VILLAGE DISTRICT DEVELOPMENT
REVIEW COMMITTEE.**

WHEREAS, the SPI-9 Buckhead Village Zoning District was adopted in 2010 and the SPI-9 Development Review Committee (DRC) was officially established by Resolution 11-R--102 to serve as an advisory group for the purpose of providing to the Director of the Office of Planning formal comments on Special Administrative Permit (SAP) applications within the District; and

WHEREAS, the SPI-9 District property owners, business owners, and residents played a significant role in crafting the SPI-9 regulations and continue to have stakeholder interest in increasing their involvement in the review of proposed redevelopments within the area to promote application of the ordinance consistent with its purposes and intent; and

WHEREAS, after over a year of operation, the existing DRC committee members and supporting City staff have determined that additional stakeholders voices providing further viewpoints and areas of expertise would prove beneficial to providing more comprehensive development review.

NOW THEREFORE THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA resolves as follows:

SECTION 1: One additional member is to be appointed to the DRC by the Councilmember in whose district SPI-9 district lies.

SECTION 2: It is the intention of the City Council that the portion of SPI-9 located east of Peachtree Road be represented on the DRC and that the portion of SPI-9 located west of Peachtree Road be represented on the DRC and that both such members be appointed by the Buckhead Community Improvement District (the "Buckhead CID").

SECTION 3: In order to carry out the intention of this Resolution as set forth in Section 2, the Buckhead CID shall appoint an additional member and shall with the appointment designate which portion of the SPI-9 district such member represents. With the appointment of the new member so identified, it shall be presumed that the Buckhead CID's already appointed member represents the other portion.

SECTION 4: After the adoption of this resolution creating the two new positions, and the appointment of the new members in a manner consistent with this Resolution, it is intended that all existing appointments to the DRC shall remain in effect and all policies and procedures of the DRC shall remain unchanged.
