# COUNCIL PRESIDENT



## **DESCRIPTION**

The council president presides at all city council meetings but is not a member of the council. They may speak on any matters before the council but cannot introduce any legislation. In order the speak, the council president must temporarily relinquish their role as presiding officer to the president *pro tempore* – a member of council chosen annually based on seniority.

The city council president is elected at-large (citywide) and serves a four-year term. There are no term limits for the council president.



Atlanta Public Schools is an independent system with <u>no</u> governance from the mayor or city council. The school board is elected separately and hires the superintendent.

# **QUALIFICATIONS**

Council president candidates must:

- be at least 18 years old, a resident of the city for at least one year, a registered voter of the city, and <u>not</u> be an employee of the city
- pay a qualifying fee of \$1,860.00 or file a pauper's affidavit showing inability to pay and obtain enough signatures on a qualifying petition
- qualify during qualifying period (August 17-20, 2021) or file notice
  of intention as a write-in candidate (by August 27, 2021) and publish
  notice in the *Fulton County Daily Report*

## **SALARY**

Starting in 2022, the council president will receive an annual salary of \$74,400.

## **APPOINTMENTS**

The council president appoints chairs and members of each of the council's standing committees:

- City Utilities
- Committee on Council
- Community Development Human Services
- Finance / Executive
- Public Safety
- Transportation
- Zoning

#### DID YOU KNOW?



The council president only votes on legislation in the case of a 7-7 tie.



The council president exercises all powers and discharges all duties of the mayor in case of a vacancy in that office or during the disability of the mayor.

#### MUNICIPAL ELECTION DATES


Voting for Mayor, City Council President, City Council, Board of Education (School Board) and Municipal Judges:

Tuesday, November 30, 2021: run-off election


A run-off election will occur for any race where no candidate receives more than 50% of the vote.


## ATL DEMOGRAPHICS
